BUSINESS TERMS AND CONDITIONS

Axiski Limited™ Trade Sales Terms & Conditions (hereafter referred to as Axiski) effective 9th October 2018

By placing an order with Axiski, you agree to be bound by these terms and conditions, and confirming that you are either:

- a retailer with the purpose of selling Axiski products to the consumer or
- a distributor or wholesaler with an agreement in writing from Axiski to re-sell to selected retailers (online and/or brick-and-mortar).

Price (all prices are exclusive of local taxes)

A detailed price list is available on request. Orders are in the agreed currency and accepted on a "Date on Dispatch" basis. Axiski reserves the right to change prices without notice prior to accepting a purchase order.

Orders

The minimum order value to open an account is £375 GBP or €436.80 EUR of available stock. In the UK, deliveries of £500 or more will have carriage included in the delivery. Orders of less than £500 will incur a carriage charge of 4% of the value.

Non-UK deliveries are all priced as ex-Warehouse.

- Throughout mainland Europe, a minimum delivery charge of €35 applies for up to 50 units. For more than 50 units, the delivery price is between 5% - 8% of the order value
- Any remaining countries carriage charges will be on a case by case basis.

A forward order book will be maintained on a "first come first served" basis for new stock, new releases and seasonal variations.

Payment & Settlement Terms

Initial orders are on a Pro-forma basis only. A 30-day credit account may then be offered. Axiski operates a strict 30 days net payment term unless changed in writing. Credit accounts may be withdrawn without notice if terms are not adhered to.

Axiski Brand

Axiski has the stated intention of building the Axiski brand and trademark into a property with long-term value. Traders are selected on the basis of their agreement to be bound by measures that support this. The images and brand can only be used to assist the Axiski products and brands.

Ownership of the goods

Until all outstanding amounts have been paid in full, the goods will remain the only & absolute property of Axiski, such as legal & equitable owners. Goods will be stored in a way that makes them easily identifiable. You are authorised to sell the Reserved Goods under the express terms that the entire proceeds thereof will be held in trust for Axiski Ltd. This is without prejudice to any other legal remedy.

Returns

Damaged and defective goods must be reported by e-mail to info@axiski.com within seven days of receipt. A Return Goods Authorisation (RGA) will be created by the Sales Office if goods are authorised to be returned to the warehouse. Goods returned without an RGA will not be processed, and will be returned to the sender at the sender's expense.

Modification

Axiski reserves the right to improve or withdraw its products without notice. Descriptions and sizes are for guidance only, and customers should satisfy themselves about the suitability of the product.

Selling Platforms

You agree that you will only sell Axiski within your own e-commerce store (your website) and/or within your physical store. You may not, unless given written permission by Axiski, sell Axiski on Amazon, eBay or any other similar online marketplace.
